




A SPINNING IN SCREEN EFFECT FLIPS OVER TO REVEAL THE NEXT SHOT





Lawyer, "just for being found sitting..."



IN SCREEN EFFECT SHRINKS IMAGE TO







CUT TO A BEE LOOKING SHIFTY









MEADOW








"Were you forced to wear human clothes at your trial?"

CUT TO A WIDER SHOT TO INCOPORATE IN SCREEN EFFECTS OF THE STILLS POPPING ON AROUND HIM










MID SHOT OF LAWYER LAUGHING IN A CHEESY INGRATIATING WAY.


ZOOM INTO CU OF LAWYER.

HAVE A SPARKLE EFFECT ON HIS TEETH AFTER HE SAYS THE "YOU"








CUT TO A MID SHOT AS LAWYER PUTS HAND ON HIPS


HE NOTICES THE RAT SITTING ON THE CHAIR


Lawyer, "Unless you're a group of rats facing persecution..."

RAT LOOKS AT THE LAWYER



CRASH ZOON INTO AN EXTREME CLOSE UP OF HIS FACE








CU OF LAWYER DARK AND FOREBODING

CUT TO MID SHOT AS HE WHIPS AROUND TO INTRODUCE BARTHOLOMEW


Lawyer, "Bartholomew Chassenee!"

WHIP PAN TO...




Bart,"I defended some rats after they were accused..."


Bart cont'd, "...of destroying the local barley crops."




Bart cont'd, "But that the journey to the courtroom was too perilous..."

CUT TO MID SHOT AS RAT POPS UP ON HIS HEAD. HE DOESN'T REACT.




TRACK OUT TO REVEAL PEASANT DISTRAUGHT BY THE SIGHT OF THE MILES OF DESTROYED BARLEY.



Lawyer, "Due to the numbers of their..."


BARTHOLOMEW RAISES A CAT MUG SHOT AND THE RAT LOOKS TERRIFIED AND DROPS BEHIND BART








CU OF THE TOP OF BARTS HEAD TO SEE THE SCRED RAT POP UP AND LOOK AROUND NERVOUSLY









Bart cont'd, "cats-lying in wait along the way."



THE RAT IS SHAKING AND HIS CHEST HEAVES UP AND DOWN IN FEAR AS THE CAT GETS CLOSER.








